As part of the project, Marin Transit would develop the site with a new building dedicated to District operations; visitor, employee, and bus parking; maintenance, charging, potential solar panel infrastructure; and fencing. The project will support both diesel-electric hybrid buses and electric buses, so a diesel refueling station will be included to service diesel-electric hybrid buses until the transition to an all-electric fleet. The project would include an 18,600 square-foot building in the approximate middle.
